- In order to expedite processing 2 blank checks must be provided at the drawing for order on the day of the sale. Each check must be signed and made payable to the Boone County Clerk.
- Submission of list does not guarantee purchase of tax bills.
- All submitted lists are final, no additions can be made once submitted
